The resident gains experience creating, implementing, and optimizing population health initiatives with our evidence-

based prescription drug program (EBRx), the UAMS Medical Center, and Healthplan PBM. Involvement in quality improvement and multiple projects is expected. The resident will teach in EBM and U.S. Healthsystems in the pharmacy curriculum. Upon successful completion of the program, residents are awarded a Residency Certificate. Application Process

Eligibility

Applicants must possess a degree in pharmacy from an American Council on Pharmaceutical Education (ACPE) accredited college. The applicant must have completed or in process of completing an ASHP-accredited PGY1 residency. The Applicant must be eligible for licensure in the state of Arkansas and a member of ASHP. The PGY2 PHMDA Pharmacy Residency has candidate status for accreditation by ASHP.

Applicants must submit the following documents via PhORCAS by January 4:

- Letter of intent
- Curriculum vitae
- Three (3) letters of recommendation, including one (1) from PGY1 Residency Director
- Official transcript from pharmacy school
